1. Approval of Agenda

S. Brown reported the first ballot for honorary degrees would be held after item 5. Question Period.

Moved by G. Logan, seconded by L. Lewis approval of the minutes of October 28, 2002 as amended. CARRIED.

3. Business Arising from the Minutes

There was no business arising from the minutes.

4. President's Announcements

S. Brown reported the Maclean's Canadian university rankings were published on November 11, 2002 and MSVU ranked 12th. This was up from the previous year's ranking of 16th. She noted that MSVU had put particular emphasis on the scholarships and bursaries area, which received a ranking of 14th, improved from16th. Other areas of significant movement included the number of undergraduate full time international students, (to 6th from 15th), and Social Sciences and Humanities Research Grants, (to 9th from 13th). Maclean's also made a change in methodology this year in terms of how it measures class size, and in addition to the distribution and number of classes of a certain size, it now considers the proportion of students likely to experience small classes in the course of their tenure at the university. Due to this change, MSVU moved to the top of that category for third and fourth year classes, and to second in the category for first and second year classes. Overall, MSVU improved on 9 indicators, remained constant on 5 and declined on 5 indicators.

S. Brown read a memo from L. Theriault, which reported the Academic Appeals Committee has concluded one hearing and received two more appeals from students. These hearings will be scheduled in the next week. The Committee will also be considering a memo received from the Committee on Teaching and Learning regarding Prior Learning Assessment appeals.

7.3 Academic Policy and Planning

7.3.1 Program Review Schedule

D. Woolcott reported the Committee on Academic Policy and Planning (CAPP) has been meeting regularly and is preparing its report on the Review of Academic Program Reports for the Departments of Chemistry/Physics and Modern Languages to bring to Senate. She noted the change in the Academic Program Review Schedule, which had been circulated with the agenda. Department Chairs had requested that CAPP delay the review of the Department of Mathematics and Computer Studies and the Department of Information Technology.

7.3.2 Academic Calendar Dates, 2003-2004

D. Woolcott, as Chair of CAPP, presented the proposed list of Academic Calendar Dates for 2003-2004. She explained that in an attempt to meet the number of Mondays required for a semester and to avoid the confusion of making a Wednesday a Monday, the Committee on Academic Policy and Planning decided to hold the 2003 fall study day on Wednesday. A considerable discussion ensued regarding the proposed November 12, 2003 fall study day.

Moved by S. Drain, seconded by L. Lewis that the dates for the fall study break be amended to call Wednesday, November 12, 2003 a Monday, and make Monday, November 10th and Tuesday, November 11, 2003 holidays. DEFEATED.

Moved S. Seager, seconded by D. O'Connell that the November 12, 2003 study day be removed from the list of 2003-2004 Academic Calendar Dates. DEFEATED.

Moved S. Seager, seconded by S. Boyd that November 10 and 11, 2003 be holidays on the understanding that all Monday Only classes be 10 minutes longer, e.g. 2 hour 40 minute classes rather than 2 hour 30 minute classes. DEFEATED.

Moved D. Woolcott, seconded by S. Drain approval of the Academic Calendar Dates for 2003-2004 as recommended by the Committee on Academic Policy and Planning. CARRIED.
